## **Gaming4Life 2020 Charity Stream Competition - Terms and Conditions**

By entering the Gaming4Life 2020 Charity Stream Competition, you agree to be bound by these Terms and Conditions.

THE TERMS SET OUT BELOW HAVE SPECIAL MEANINGS:

"AEDT" means Australian Eastern Daylight Time.

"COMPETITION" means the Gaming4Life Charity Stream Event.

"EVENT PRIZE"" means the Gaming4Life prize.

"EVENT" means that event which commences at 9.00am AEDT February 1, 2020 to 11:59pm AEDT on February 23, 2020 during which gaming streamers will endeavor to raise funds for "Sony Foundation's Bushfire Appeal", the Promoter's fundraising appeal through his/her "Fundraising Event" page for the Promoter's "Gaming4Life" hosted by Tiltify.com by streaming from his/her Twitch Channel.

"PROMOTER" means Sony Foundation Australia, ACN 086 967 222 at 11-19 Hargrave Street, East Sydney, NSW 2010, Australia.

"TWITCH CHANNEL" means a streamer's channel which they have registered with Twitch and use for game streaming (Twitch's homepage is at <a href="https://www.twitch.tv/">https://www.twitch.tv/</a>).

"Streaming Entrant" means they have a registered a fundraising page as part of Gaming4Life 2020 (https://tiltify.com/sony-foundation-australia/gaming4life-2020-australian-bushfire-appeal)

#### PART A: ELIGIBILITY AND ENTRY REQUIREMENTS

- 1. Eligibility
- 1.1. This Competition is open to gaming streamers who have a Twitch Channel and link this to a "Fundraising Event" page that they have opened via the Promoter's Tiltify.com Gaming4Life webpage (at <a href="https://tiltify.com/sony-foundation-australia/gaming4life-2020-australian-bushfire-appeal">https://tiltify.com/sony-foundation-australia/gaming4life-2020-australian-bushfire-appeal</a>) who fulfill the entry terms and conditions described below.
- 2. Entry Period

The entry period commences at 9.00am AEDT on February 1, 2020 and concludes at 11:59pm AEDT on February 23, 2020 (inclusive).

#### PART B: HOW TO ENTER

3. Entry

7.2. # PART F: GENERAL

- 11. General Competition
- 11.1. By entering the Competition, each entrant accepts and will be bound by these Terms and Conditions.
- 11.2. No applications from agents, third parties, organised groups or applications automatically generated by computer will be accepted. No entries not in accordance with these Terms and Conditions or any other entry instructions will be accepted.
- 11.3. The Promoter does not accept responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft, destruction, alteration of or unauthorised access to entries (including the entrant's Twitch Channel and their "Fundraising Page" Gaming4Life webpage), or such entries being lost, damaged or delayed as a result of server functions, technical issues, virus, bugs or other causes outside the Promoter's reasonable control.
- 11.4. The Promoter reserves the right to disqualify any entrant if it has reasonable grounds to believe the entrant has failed to raise funds for the Promoter.
- 11.5. In the event of unforeseen circumstances or in its absolute discretion if it so wishes to do so, the Promoter reserves the right to (i) substitute the Gaming4Life Prize (or any part of it) for an alternative of equal or greater value; and/or (ii) amend, alter or cancel the Competition. No cash alternative will be offered. In the event of cancellation/amendment of the Competition or substitution of the Gaming4Life Event Prize, each entrant expressly agrees that, to the fullest extent permitted under applicable laws, no entrant will be entitled to any compensation.
- 11.6. No expenses will be covered other than those expressly stated to be covered in these Terms and Conditions.
- 11.7. The entrant who wins the Gaming4Life Prize may be required to pay tax on the Gaming4Life Prize in accordance with their jurisdiction's tax legislation. Independent financial advice should be sought.
- 11.8 Any unused portion of the Gaming4Life Prize, is not transferable or exchangeable and cannot be taken as cash and in the event that the winner does not take any element of the Gaming4Life Prize then that element will be forfeited and cash will not be supplied in lieu of that element of the prize.
- 11.9. The Promoter and its associated agencies and companies will not be liable for any loss (including, without limitation, special, indirect or consequential loss or loss of profits), damage, expenses, personal injury or death which is suffered or sustained (whether or not arising from any person's negligence) in connection with this Competition including accepting and participating in the Gaming4Life Event, except to the extent that any liability cannot be excluded by law (in which case, the liability is limited to the

minimum allowable by law). Each entrant is responsible for managing his/her health and wellbeing during this Competition including during the Event.

- 11.10. These Terms and Conditions shall be governed by the laws in New South Wales, Australian and each party submits to the non-exclusive jurisdiction of the courts of New South Wales, Australia and any courts which have jurisdiction to hear appeals from any of those courts over any dispute arising from the Competition and/or the Gaming4Life Prize and waives any right to object to any proceedings being brought in those courts.
- 11.11. In these Terms and Conditions, unless otherwise specified, reference to: (i) "includes" and "including" shall mean includes and including without limitation; (ii) the Promoter includes its permitted assignees and/or the successors in title; (iii) a statute or statutory instrument or any of their provisions is to be construed as a reference to that statute or statutory instrument or such provision as the same may have been or may hereafter be amended or re-enacted; (iv) words denoting the singular shall include the plural and vice versa and words denoting any gender shall include all genders; and (v) the headings in these Terms are for information only and are to be ignored in construing the same.
- 11.12. The decision of the Promoter is final and no correspondence or discussion will be entered into.
